Project closing

- Physical closing: <u>30/06/2019</u>
 - All technical tasks must be terminated
 - All expenses must be invoiced

- Administrative closing: 31/10/2019 (ES, PT), 30/11/2019 (FR)
 - Only administrative expenses linked to the closing of the project will be accepted

Deadline for final report

4 months after the end of the project

5 months for the French partners

- End of the project: <u>30/06/2019</u>
- Deadline for submitting final report to EFI:
 - 31/10/2019: Spanish and Portuguese partners have to have their reports validated by the <u>national correspondent</u>
 - 30/11/2019: French partners have to have their reports audited
- After the deadline EFI has 15 days to **submit** the report to **INTERREG**: 15/11/2019

Expenses for administrative closure

Accepted after the end of the project: 30/06/2019

Expense	Why	How to justify it
Personnel costs	To carry out all tasks linked to the administrative closure of the project	 To declare in a reasonable way the personnel time needed to close the project
Audit	Final audit done after the end of the project	 To include the expense in the final report without including the invoice To submit the report to the auditor The auditor does the audit, but does not close it, the report is opened again for corrections The auditor is paid ans the invoive is included in the report. The report can now be submitted

Total budget and changes

• The total budget allocated to the project cannot be overspend

The budget can be redistributed bewteen partners

• Respecting the rule of 15%:

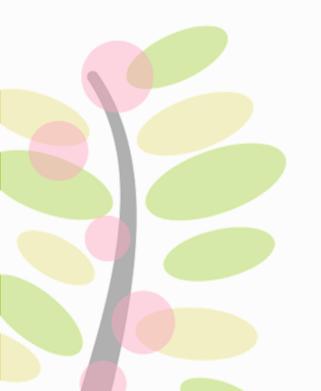
• Budget changes are accepted in the limit of 15% for each category

Special cases

• Cross-cutting tasks: GT.T1, GT.T2 and GT.T3, cannot be more than 25% of the total budget of the project

Human Ressouces: cannot be more than 65% of all costs
